

YIPPI “UEFA EURO 2020 PREDICT & WIN” Contest Terms and Conditions

The EuroCup2020 Predict & Win (hereinafter, the “Contest”) is a global competition organized by TOGA LIMITED in its official Yippi App (hereinafter, “YIPPI”). The Contest starts on 9th June 2021 at 12:00 a.m. GMT 8+ and closes on 12th July GMT 8+ (hereinafter, the “Contest Period”) in which it allows the Yippi users to predict and win Yipps by following the rules and terms and conditions of this Contest.

1. Acceptance

- 1.1. By entering this contest, the participant agrees to be bound with these Terms and Conditions, which he/she acknowledges to have read and understood.
- 1.2. By entering this contest, the participant agrees that YIPPI may use his/her personal details submitted with his/her entry only for the purpose of administering the contest and in accordance with YIPPI’s Privacy Policy.
- 1.3. The participant agrees that YIPPI reserves the right to publish without compensation his/her photo and/or full name in case he/she is the winner and the participant waive all rights with respect to printed, broadcast and other forms of publicity.
- 1.4. By participating in this contest, you agree to release and hold YIPPI, its subsidiaries, directors, employees, representatives, agents, sponsorship partners from any liability in connection with the contest or, if declared winner(s), the prize(s) awarded and use thereof.
- 1.5. YIPPI reserves the right to change the Terms and Conditions for this contest at any time without giving any reason or prior notice.

2. Eligibility and Entry restrictions

- 2.1. To be eligible to participate, you must:
 - 2.1.1. be 18 years of age and above or legal age to participate in such contest in the country;
 - 2.1.2. have a genuine Yippi account;
 - 2.1.3. predict the winner and follow any such participation rules as may be published by YIPPI on its official Yippi page from time to time; and
- 2.2. You agree and understand that the maximum number of entries to the contest per participant is 1, that is, the participant can only make one and final prediction for each match;
- 2.3. The contest shall open and close for entries at the time and on the date specified by YIPPI on the relevant contest’s post.
- 2.4. Any modification brought to prediction thereafter shall automatically amount to an invalid entry.
- 2.5. Any entries received before and/or after the contest period will be invalid and will not be entered.
- 2.6. Misrepresentation or non-compliance by a participant with the criteria above will result in automatic disqualification.

3. Prizes

- 3.1. Total prize pool is up to 54,000 Yipps for the Contest Period
- 3.2. A total prize of 1000 Yipps will be divided to all the winners of each match. (Total 51 match fixture). Each winner will be credited the Yipps within seven (7) business days upon completion of each match.

- 3.3. Additional prizes for “Predictor Board”. This “Predictor Board” winners will be announced on 20th July 2021 (or upon completion of the final match set) and the winners will be credit with Yipps within seven (7) business days.
 - 3.3.1. Top 1: 888 Yipps
 - 3.3.2. Top 2: 588 Yipps
 - 3.3.3. Top 3: 388 Yipps
 - 3.3.4. Top 4 – 10: 188 Yipps each winner

4. General Terms and Conditions

- 4.1. All the participant of the Contest is bound by the Yippi App Terms of Use and Privacy Policy.
- 4.2. The Yipps cannot be exchanged for cash.
- 4.3. The participants acknowledge and accept that the choice to select one or several winners is entirely at the sole discretion of YIPPI;
- 4.4. A system draw will be affected to pick the winner and/or winners shall there be more than one winner with similar accumulated Yipps
- 4.5. YIPPI’s decision regarding the selection of the winner and/or winners shall be final and binding. No claim or dispute whatsoever regarding the decision shall be entertained in this regard.
- 4.6. If YIPPI cannot successfully contact the winner and/or winners after five (5) business days of reasonable effort, or if the winner(s) is unable or unwilling to accept the prize then YIPPI shall be entitled to award the prize to the next eligible winner(s).
